- THE INTIMATE PARTNER ABUSE PROGRAM'S SAFE FAMILIES OFFICE, THE ONLY LAWYER-STAFFED, COURTHOUSE-BASED WALK-IN LEGAL CLINIC IN THE STATE THAT ASSISTS ALL SURVIVORS OF INTIMATE PARTNER ABUSE REFERRED BY THE COURTS WITH FILING FOR PROTECTIVE ORDERS, WAS NAMED A NATIONAL BEST PRACTICES MODEL IN 2018 BY THE AMERICAN BAR ASSOCIATION'S COMMISSION ON DOMESTIC AND SEXUAL VIOLENCE, FOLLOWING PREVIOUSLY BEEN NAMED SO IN 2009 WHEN IT FIRST OPENED.

- THE GUARDIAN AD LITEM PROGRAM IS SO EFFECTIVE AT SERVING THE COURTS AND CHILDREN THAT IN 2018, THE COURT MADE 88 REQUESTS FOR GALs, A 184 % INCREASE IN REQUESTS FROM THE PREVIOUS TWO YEARS.

- IN 2018, OUR SOCIAL WORKERS WERE ABLE TO EXPAND THE CAPACITY IN WHICH THEY ASSIST SURVIVORS IN MAINTAINING THEIR INDEPENDENCE BY IDENTIFYING GAPS IN THEIR FINANCIAL NEEDS AND PROVIDING FINANCIAL ASSISTANCE TO PREVENT HOUSING DISPLACEMENT AND UTILITIES BEING DISCONNECTED. THESE TYPES OF HARDSHIPS ARE FREQUENTLY WHAT DRIVE SURVIVORS BACK TO AN ABUSER ON WHOM THEY WERE FINANCIALLY DEPENDENT AND THEIR ABILITY TO PROVIDE SUCH ASSISTANCE HELPED MANY SURVIVORS FULLY BREAK FREE FROM THEIR ABUSERS.

- IN 2018, OUR FAMILY LAW PROGRAM CONTINUED TO MEET THE GREATEST CIVIL LEGAL UNMET NEED FOR SURVIVORS OF INTIMATE PARTNER ABUSE BY PAIRING SURVIVORS WITH MEMBERS OF THE METRO ATLANTA FAMILY LAW BAR WHO VOLUNTEERED THEIR TIME TO REPRESENT SURVIVORS FOR FULL REPRESENTATION IN 19 CASES.
